## Come August, Come Freedom notes on extracts 09.03.2012

Extract #1, p. 9, Advertisement, *Virginia Gazette*: This is an authentic newspaper ad, placed in the *Virginia Gazette*. I changed the names to reflect Old Major and Henrico County. The actual ad was from Stafford County about one hour north of Henrico, the enslaved man was named Charles. I also edited slightly for readability.

Extract #2, p. 15, Thomas Prosser Daily Journal: This is a fabricated journal entry modeled after an unpublished privately held plantation journal of John Tinsley in Hanover County during the same time period.

Extract #3, p. 36, Advertisement, *Virginia Gazette:* This is an authentic newspaper ad, placed in the Virginia Gazette in July 1762. Edited.

EXTRACT #4, p. 43, Prosser's Brookfield: This is an illustration modeled after an authentic insurance drawing of Brookfield from 1806.

Extract #5, p. 79, Pound Cake: Authentic recipe from Mary' Randolph's cook book *The Virginia Housewife*, 1824, and still in print.

Extract #6, p. 92, 1795, Brookfield Shop Jobs: This is a fabricated blacksmith shop list. I consulted an 1854 blacksmith invoice from the Tinsley family papers [Hanover VA] and also a James Anderson blacksmith log [Richmond, VA] from 1790s for the types of jobs Gabriel may have performed on Brookfield, as well as for spelling customs of the period.

Extract #7, p.107, Thomas Prosser Daily Journal: This is a fabricated journal entry modeled after an unpublished privately held plantation journal of John Tinsley in Hanover County (10 miles from Brookfield) during the same time period. I changed the dates, names, etc to fit the story, but the types of entries: concern with the fields, concern with going to town, and giving his son money occur in the diary of a contemporary of Thomas Prosser's from the same region.
